 - A. 2024 General Fund Budget

Ms. Rabuck advised since the September Budget Workshop meeting there were two changes to the expenditures. One was the reduction of NW EMS Ambulance from \$15,000.00 to \$13,000.00 and the other was an increase of \$500 for Clean Up Days.

Ms. Rabuck provided three comparisons for tax millage with the sale of the 215 Falmouth Road property. Option A would utilize \$75,000.00 of property sale proceeds with a 1.35 millage rate; Option B would utilize \$120,000.00 of property sale proceeds with a millage rate of 1.15; Option C would utilize \$180,000.00, which is the appraised value, of property sale proceeds with a millage rate of .90.

Motion by Mr. Risser to move the General Fund budget along with utilizing \$180,000.00 of the property sale proceeds with a millage rate of .90, seconded by Mr. Williams. Motion approved 3-2, with Ms. Mariani and Mr. Mohr voting against.

B. 2024 Small Funds Budgets

Ms. Rabuck advised there have been no changes to the Small Funds Budgets since the September Budget Workshop meeting.

Moton by Mr. Hawthorne to move the Small Funds Budgets along, seconded by Ms. Mariani. Motion approved 5-0.
