After discussion with Contech, the required length of the culvert necessary to meet minimum clearances from the end on the culvert and consideration for the skew of the culvert requires us to update the culvert permit as the GP-11 coverage restrictions are exceeded. The bidding schedule is subject to receipt of the small project permit. Bid documents are very similar to Risser Road and will be ready well before the permit is received. Our plan is to bid the project in April and commence construction in June. We anticipate a 4 to 6 week construction schedule.
