In consideration of the permission granted by the undersigned parent or guardian to allow minor children to enter the premises known as Guppy Gulch and/or participate in activities thereon, the undersigned parent or guardian, does hereby waive, release, and hold harmless Stephen Deem and Guppy Gulch, LLC from any and all claims including any liability from claims that arise from negligence and I further agree to promptly indemnify, defend and hold harmless Stephen Deem, Guppy Gulch LLC, its owners, employees, officers, directors, and agents from and against any and all losses, costs (including but not limited to litigation costs and counsel fees), claims, suits, actions, damages, expenses and liabilities, regardless as to whether such claims are alleged to have been caused in whole or in part by the acts, omissions or negligence of Stephen Deem, Guppy Gulch LLC, its owners, employees, officers, directors, and agents in connection with my participation at Guppy Gulch or related activities.
